

AFGHANISTAN

TOURIST VISA

1. Original Passports with minimum 6 months validity from date of travel and must have 2 or more blank pages.
2. Visa Application Form to filled and duly signed by the applicant.
3. 2 recent photographs 35 X 45mm, proper white background, and matt finish 70% face size.
4. Covering letter from applicant mentioning the purpose of travel and duration of stay.
5. Applicant's physical presence is mandatory.
6. Passenger is required to take Oral Polio vaccination 4 week prior to Travel, the same is mandatory travel requirement.
7. In case of entry visa, the applicant must have an invitation letter approved by the Consular Department, Ministry Of Foreign Affairs of The Islamic Republic of Afghanistan.

BUSINESS VISA

1. Original Passports with minimum 6 months validity from date of travel and must have 2 or more blank pages
2. Visa Application Form to filled and duly signed by the applicant.
3. 2 recent photographs 35 X 45mm, proper white background, and matt finish 70% face size.
4. Covering letter from applicant mentioning the purpose of travel and duration of stay
5. Applicants physical presence is mandatory
6. Passenger is required to take Oral Polio vaccination 4 week prior to Travel, the same is mandatory travel requirement.
7. Invitation letter required from Afghani Company.
8. A letter of recommendation from the Indian chamber of Commerce.
9. Correspondence of business is required.
