

ARGENTINA

TOURIST VISA

1. Original Passports with minimum 6 months validity from date of travel and must have 2 or more blank pages.
2. Visa Application Form to filled and duly signed by the applicant.
3. 2 recent photographs 4x4 cm, proper white background, and matt finish 80% face size.
4. Covering letter from applicant mentioning the purpose of travel and duration of stay with concise program of trip notarized by the local Public Notary.
5. Confirm Air Tickets.
6. NOC letter from the current employer if employed.
7. Original updated bank statements for last 6 months stamped and signed by the bank.
8. Last 3 years ITR (Income Tax Return).
9. Copy of an international credit card copy + statement.
10. Travel Insurance for the entire duration.
11. Salary Slips for Last 3 months if employed.
12. Hotel reservation in Argentina: either guaranteed by a credit card or paid in full
13. Confirm Air Tickets.
14. Retirement Proof – pension passbook/slips – if retired.
15. In case of self-employed a registration of the company/ partnership deed/Memorandum of Articles required.

BUSINESS VISA

1. Original Passports with minimum 6 months validity from date of travel and must have 2 or more blank pages
2. Visa Application Form to filled and duly signed by the applicant.
3. 2 recent photographs 4x4 cm, proper white background, and matt finish 80% face size.
4. Covering Letter from the Company / Organization (the covering letter should be translated in Spanish and attested by the India Notary public). The covering letter





should be addressed to the VISA OFFICER, Embassy of Argentina, New Delhi. The letter should be in detail and cover the following details:

A brief profile of the corporation / company / business (2 Copies translated In Spanish language)

Full name, nationality and passport number of the applicant and his Position / title in the Organization.

Details of the purpose and duration of the visit; full names, addresses and telephone Numbers of all businesses and person you will contact in Argentina, and whether your employer assumes moral and financial responsibility while the applicant is in Argentina.

The letter must be in original (no photocopies or faxes will be accepted) written in or Translated into Spanish, on company letter head signed by the person in charge, (other than the applicant).

If the applicant is going to a Trade Fair, Congress (commercial / economic issues) or Exhibition, he must accredit the inscription on the fair or exhibition to which is going to attend

5. NOC letter from the current employer if employed
6. A confirmation letter from a Chamber of Commerce or Industry/Trade local Institution, attesting the membership of the Company or, a certified copy of the official "Certificate of Incorporation" of the Company with the India Ministry of Industry and Commerce.
7. Invitation letter from the Argentina Company certified by an Argentinean Notary Public AND then attested by the "Colegio de Escribanos".
8. Note: The letter must be in original form (no photocopies or faxes will be accepted), written in or translated into Spanish, on company letter-head paper, signed by the person in charge.

9. If going to a Trade Fair, Congress (commercial/economic issues) or Exhibition, he must accredit the inscription of the fair or exhibition to which he/she is going to attend in the RENURE.
 10. Hotel reservation in Argentina: either guaranteed by a credit card or paid in full.
 11. Confirm Air Tickets. One way tickets not accepted.
 12. Income Tax Returns or Form 16 for last 3 years.
 13. Original Personal & Company Bank Statements for Last 6 months with bank seal & sign.
 14. Copy of an international credit card.
 15. Salary Slips for Last 3 months if employed.
 16. Travel Insurance.
