TOURIST VISA

1. Original Passports with minimum 6 months validity from date of travel, also attach old passports (if any).
2. Visa Application Form to filled and duly signed by the applicant.
3. 2 recent photographs 35 x 45 mm, proper white background, and matt finish 80% face size.
4. Covering letter from applicant mentioning the purpose of travel and duration of stay and addressed to – The Visa Officer, Embassy of the Federative Republic of Brazil, New Delhi.
5. Hotel confirmation.
6. Ticket Itinerary.
7. Day to Day Itinerary.
8. Original leave letter from Employer/School/College.
9. Company registration proof/ eg. Shop Act / MOA / Deed etc.
10. Income tax returns/Form 16 for last 3 years. Notarized and Attested by respective Home Departments.
11. Original personal Bank Statements for last 6 months updated with healthy balance and bank seal & sign.
12. Salary Slips for last 3 months. (If employed)
13. Retire proof /Pension order. (If retired)
14. Student id proof / Bonafide Certificate. (If student)
15. Yellow Fever required by immigration while return to India.
16. **In case of Visit:** An original notarized invitation letter from the invitee along with his passport & visa copy and the copy of RNE (Registro Nacional de Estrangeiros).





BUSINESS VISA

1. Original Passports with minimum 6 months validity from date of travel, also attach old passports (if any).
2. Visa Application Form to filled and duly signed by the applicant.
3. 2 recent photographs 35 x 45 mm, proper white background, and matt finish 80% face size.
4. Covering letter on company letterhead mentioning name, designation department and contact number of the applicant, the letter should also mention company profile and addressed to – The Visa Officer, Embassy of the Federative Republic of Brazil, New Delhi
5. An endorsement letter from "The Chambers of Commerce/Export Promotion Council/Manufactures Association" with which the applicants company has been registered mentioning that the applicant is an Employee of the said company and the association has no objection in applicant\'s visit to Brazil.
6. An Original Notarized Invitation Letter from inviting Company on its letter head stating the name of the applicant, the purpose of travel, dates and duration of stay. It should be duly signed with the signatory's name and designation along with the registration number of the company.
7. Ticket itinerary.
8. Company registration proof/ eg. Shop Act / MOA / Deed etc.
9. Income tax returns/Form 16 for last 3 years. Notarized and Attested by respective Home Departments.
10. Original personal Bank Statements for last 6 months updated with healthy balance and bank seal & sign.
11. Salary Slips for last 3 months. (If employed)
12. Yellow Fever required by immigration while returning back to India.
