TOURIST VISA

1. Original Passports with minimum 1 year validity from date of travel.
2. Visa Application Form to filled and duly signed by the applicant.
3. 3 recent photographs 3 x 3 cm, proper white background, and matt finish 80% face size.
4. Covering letter from applicant mentioning the purpose of travel and duration of stay and the details of the person whom he/she is going to visit in Colombia.
5. Hotel Bookings / Invitation letter from Colombia.
6. Authority letter on 100 Rs stamp paper for submission and collection of Visa application on behalf of the client.
7. Confirmed return air ticket.
8. Original personal bank statements for last 6 months updated with bank seal & sign and sufficient balance.
9. Last 3 years ITR (Income Tax Return).

BUSINESS VISA

1. Original Passports with minimum 1 year validity from date of travel.
2. Visa Application Form to filled and duly signed by the applicant.
3. 3 recent photographs 3 x 3 cm, proper white background, and matt finish 80% face size.
4. Covering letter from Indian company mentioning the profile of company, applicants details/position in the company and reason of sending him/her to Colombia. Company also has to give an undertaking to pay all the expenses of the applicant's stay in Colombia.
5. Recommendation Letter from Chamber of Commerce.
6. Confirmed return air ticket.
7. Invitation letter from the Colombian company taking responsibility of the applicant.

8. Original personal bank statements for last 6 months updated with bank seal & sign and sufficient balance.
 9. Last 3 years ITR (Income Tax Return).
 10. Authority letter on 100 Rs stamp paper for submission and collection of Visa application on behalf of the client.
