

CROATIA

TOURIST VISA

1. Original Passports with minimum 6 months validity from date of travel, also attach old passports (if any).
2. Visa Application Form to filled and duly signed by the applicant.
3. 2 recent photographs 35 x 45 mm, proper white background, and matt finish 80% face size.
4. Covering letter from applicant mentioning the purpose of travel and duration of stay.
5. Proof of Air Tickets.
6. Hotel confirmation.
7. Overseas Travel Insurance with minimum USD 50000 coverage.
8. Income Tax / Form 16 for last 3 years.
9. Salary slips for last 3 months (If employed)
10. Original Leave approval letter from Employer / School/ College. (If Employed or Student).
11. School / College Bonafide letter or ID card copy(if student)
12. Company registration proof e.g. Shop ACT, MOA, and partnership deed etc. - If Self Employed.
13. NOC letter from the current organization (employer) stating the position and the tenure of service.
14. Original Personal Bank statements stamped & signed by bank for last 6 months with good transaction history & healthy balance.

Note. Applicants Having valid Schengen Visas or National visas of Schengen Countries and residence permits of Bulgaria, Cyprus, and Romania do not require an additional (Croatian) visa for Croatia.





BUSINESS VISA

1. Original Passports with minimum 6 months validity from date of travel, also attach old passports (if any).
2. Visa Application Form to filled and duly signed by the applicant.
3. 2 recent photographs 35 x 45 mm, proper white background, and matt finish 80% face size.
4. Covering letter on company letterhead mentioning travel details, applicant details, details of the meeting/work along with contact details of the business parties involved.
5. Invitation letter from the Croatian Company mentioning the details of the meeting, applicant.
6. Proof of Air Tickets.
7. Hotel confirmation.
8. Overseas Travel Insurance with minimum USD 50000 coverage.
9. Income Tax / Form 16 for last 3 years.
10. Salary slips for last 3 months (If employed).
11. School / College Bonafide letter or ID card copy.
12. Company registration proof e.g. Shop ACT, MOA, and partnership deed etc. – If Self Employed.
13. Original Company Bank statements stamped & signed by bank for last 6 months with good transaction history & healthy balance.

Note. Applicants Having valid Schengen Visas or National visas of Schengen Countries and residence permits of Bulgaria, Cyprus, and Romania do not require an additional (Croatian) visa for Croatia.

Family and friend visit visa

1. Original Passports with minimum 6 months validity from date of travel, also attach old passports (if any).
2. Visa Application Form to filled and duly signed by the applicant.

4. Covering letter from applicant mentioning the purpose of travel and duration of stay.
5. Proof of Air Tickets.
6. Hotel confirmation.

8. Income Tax / Form 16 for last 3 years.
9. Salary slips for last 3 months (If employed).
10. Original Leave approval letter from Employer / School/ College. (If Employed or Student).
11. School / College Bonafide letter or ID card copy (if student).
12. Company registration proof e.g. Shop ACT, MOA, and partnership deed etc. – If Self Employed.
13. NOC letter from the current organization (employer) stating the position and the tenure of service.
14. Original Personal Bank statements stamped & signed by bank for last 6 months with good transaction history & healthy balance.

Documents if Visiting Friends/Family in Croatia.

1. Passport & Visa Copies of the invitee.
2. Letter of Guarantee by Natural Person (certified by a Public Notary in Croatia): in original or copy if the original is deposited at the Ministry of Foreign and European Affairs in Croatia.
3. Accommodation proof in Croatia.
4. Invitee's Bank statements last 6 months updated (If Sponsoring).
5. Salary slips for last 3 months. (If Sponsoring).
6. Relationship Status proof if invited by Family members.
