## DOMINICAN REPUBLIC

### TOURIST VISA

1. Original Passports with minimum 3 months validity from date of travel
2. 1 Complete Visa Application Form with duly stapled 1 Passport size photograph
3. Travel Itinerary and Hotel Reservation
4. Letter from the Bank providing: Date of opening of an account, annual average balance maintained during the year, Date of last Deposit. (NO BANK STATEMENTS) also should be translate in to Spanish.
5. Copies of Visa stamped pages.
6. Police Clearance Certificate is required
7. If invited by friend or relative: applicant must attach the invitation letter along with copy of the Identity/resident card of the invitee.
8. Applicant must attach the invitation letter which should be notarized and legalized by Procuraduría General de la República Dominicana and invitation letter should have a *below mentioned clause which is:*

“Garantizo que (nombre, nacionalidad y pasaporte), no permanecerá en la República Dominicana más tiempo que el concedido por la Dirección General de Migración, in solicitara residencia o cambio de estatus migratorio desde el territorio dominicano, dedicándose exclusivamente a la actividad por la cual le fue otorgado el visado. Me hago moral y económicamente responsable de su retorno a su país de Origen, asumiendo pagar a favor Del Estado Dominicano cualquier gasto en que dicha persona pueda incurrir Durante su estancia en el país, o que se origine Como consecuencial de su repatriación o deportación Del mismo”.

### BUSINESS VISA

1. Original Passports with minimum 3 months validity from date of travel
2. 2 recent photographs 35 x 45 mm, proper white background, and matt finish 80% face size
3. Original Passport
4. Proof of Air tickets and Hotel Reservation.





5. Covering letter from company mentioning the purpose of travel and duration of stay
6. Police Clearance Certificate is required
7. Invitation letter from the Dominican Company should be sent directly to the embassy via Fax
8. Original Personal Bank statements stamped & signed by bank for last 6 months with good transaction history & healthy balance
9. Company Income Tax / Form 16 for last 3 years.
10. Salary slips for last 3 months
11. Letter from the Bank providing: Date of opening of an account, annual average balance maintained during the year, Date of last Deposit.
12. If invited by DR company: applicant must attach the invitation letter in Spanish which should be notarized and legalized by Procuraduría General de la República Dominicana and invitation letter should have a below mentioned clause which is.

“Garantizo que (nombre, nacionalidad y pasaporte), no permanecerá en la República Dominicana más tiempo que el concedido por la Dirección General de Migración, in solicitara residencia o cambio de estatus migratorio desde el territorio dominicano, dedicándose exclusivamente a la actividad por la cual le fue otorgado el visado.
