



IRAN TOURIST VISA

1. Original Passports with minimum 6 months validity from date of travel, also attach old passports (if any).
2. Visa Application Form to filled and duly signed by the applicant.
3. 2 recent photographs 3 x 4 cm.
4. Personal Interview (if required).

BUSINESS VISA

1. Original Passports with minimum 6 months validity from date of travel, also attach old passports (if any).
2. Visa Application Form to filled and duly signed by the applicant.
3. 2 recent photographs 3 x 4 cm.
4. Covering letter from Indian company mentioning the purpose of travel and duration of stay.
5. Proof of Air Tickets.
6. Hotel confirmation.
7. Overseas Travel Insurance.
8. Income Tax / Form 16 for last 3 years.
9. Salary slips for last 3 months (If employed).
10. Medical reports for HIV, Hepatitis B & C and Tuberculosis is required.
11. Recommendation letter from Chamber of Commerce.
12. Original Leave approval letter from Employer / School/ College. (If Employed or Student).
13. Company registration proof e.g. Shop ACT, MOA, and partnership deed etc. – If Self Employed.
14. Invitation letter from a company in Iran to be directly faxed to the embassy.
15. Original Personal & company Bank statements stamped & signed by bank for last 6 months with good transaction history & healthy balance.
