BUSINESS VISA

- 1. Original Passports with minimum 6 months validity from date of travel, also attach old passports (if any).
- 2. Visa Application Form to filled and duly signed by the applicant.
- 3. 2 recent photographs 35 x 45 mm, proper white background, and matt finish 80% face size.
- 4. Covering letter from applicant on company's letter head mentioning the purpose of travel and duration of stay.
- 5. Employment letter from the current organization (employer) stating the position and the tenure of service.
- 6. Yellow fever certificate.
- 7. Invitation letter from the Nigerian Company, it must have the stamp of the Nigerian Company on it. The name and phone number of the authorized signatory should be mentioned on the letter.
- 8. Company registration proof of the invitee company.
- 9. Income Tax / Form 16 for last 3 years.
- 10. Salary slips for last 3 months (If employed).
- 11. Invitee company authorized signatory's photo id proof is mandatory.
- 12. Company registration proof e.g. Shop ACT, MOA, and partnership deed etc. If Self Employed.
- 13. Original Personal & Company Bank statements stamped & signed by bank for last 6 months with good transaction history & healthy balance.
- 14. Polio Vaccination 4 weeks prior travel date has been made mandatory.

FAMILY and FRIEND VISIT VISA

- 1. Original Passports with minimum 6 months validity from date of travel, also attach old passports (if any).
- 2. Visa Application Form to filled and duly signed by the applicant.





- 3. 2 recent photographs 35 x 45 mm, proper white background, and matt finish 80% face size.
- 4. Covering letter from applicant mentioning the purpose of travel and duration of stay.
- 5. Invitation Letter from Inviting person in original. The person who will send the Sponsorship letter need to mention his mobile no on the invite letter, also need's to give his passport copy if he is Nigerian. In case if he/she is a foreigner then they need to give their passport copy along with their residence/work permit copy.
- 6. Yellow fever certificate.
- 7. Air Tickets.
- 8. Polio Vaccination 4 weeks prior travel date has been made mandatory.
- 9. Income tax returns/ For 16 for last 3 years.
- 10. Income Tax / Form 16 for last 3 years.
- 11. Company registration proof e.g. Shop ACT, MOA, and partnership deed etc. If Self Employed.
- 12. Original Personal & Company Bank statements stamped & signed by bank for last 6 months with good transaction history & healthy balance.
- 13. Salary slips for last 3 months (If employed).
