TURIST VISA

1. Original Passports with minimum 6 months validity from date of travel, also attach old passports (if any), all pages.
2. Visa Application Form to filled and duly signed by the applicant.
3. 2 recent photographs 35 x 45 mm, and matt finish.
4. Tourist voucher (original) , issued by the Ukrainian tourist company, also Ukraine company need to give a letter in original saying that in case deportation Agency will be responsible & (Letter should be address to The visa Officer, Ukraine Embassy, New Delhi).
5. Proof of Air Tickets.
6. Income Tax / Form 16 for last 3 years.
7. Salary slips for last 6 months (If employed).
8. Confirmation from the Ukrainian tourist company about its readiness to accept tourists.
9. Hotel Confirmation (Ukraine company/Invitee party full Name address, contact no Fax No Email ID etc. is Mandatory).
10. Company registration proof e.g. Shop ACT, MOA, and partnership deed etc. - If Self Employed.
11. Original Personal Bank statements stamped & signed by bank for last 6 months with good transaction history & healthy balance above 2 laces.
12. License Copy of the Tourist Company.
13. Copies of the licenses for the Ukrainian and Indian (Bangladeshi, Lankan, Maldivian or Nepalese) companies for conducting the tourist's activities.
14. Photocopy of the contract between Ukrainian and Indian (Bangladeshi, Lankan or Nepalese) tourist companies, which includes responsibility of the particular side for deportation of the tourist in case of readmission.





BUSINESS VISA

1. Original Passports with minimum 6 months validity from date of travel, also attach old passports (if any).
2. Visa Application Form to filled and duly signed by the applicant.
3. 2 recent photographs 35 x 45 mm.
4. Covering letter from applicant on company' letter head mentioning the purpose of travel and duration of stay.
5. INVITATION from Ukrainian company (joint ventures, joint stock companies, private persons and other types of non –government owned enterprises) duly signed and sealed by the inviting authorities and approved by(Official Invite letter should be issued by (MID) Ministry Instranikh Del)the local foreigners registration authorities (in Ukr. Language–УГІРФФ УМБС).
6. Copy of CERTIFICATE of the state registration of the company of the inviting side
7. Proof of Air Tickets.
8. Hotel Confirmation.
9. Travel Insurance for the entire duration.
10. Income Tax / Form 16 for last 3 years.
11. Salary slips for last 6 months (If employed).
12. Original Leave approval letter from Employer / School/ College. (If Employed or Student).
13. School / College Bonafide letter or ID card copy(if student)
14. Company registration proof e.g. Shop ACT, MOA, and partnership deed etc. – If Self Employed.
15. Original Personal & Company Bank statements stamped & signed by bank for last 6 months with good transaction history & healthy balance.
