

## UZBEKISTAN

### TOURIST VISA

1. Original Passports with minimum 6 months validity from date of travel, also attach old passports (if any), must have 1 Or 2 black paper.
2. Visa Application Form to filled and duly signed by the applicant.
3. 2 attached recent photographs to your application forms.
4. Copy of the letter of invitation from inviting partners in Uzbekistan (travel agents, Tourist Company or etc.) (Except for citizens of the US, Austria, Belgium, Germany, Great Britain, Italy, France, Japan, Spain, Switzerland, Latvia and Malaysia).
5. Fees. To be paid on collection only.
6. Applying by courier service or mail. Before sending your documents please contact the consular section to assure that visa issuance confirmation of the Ministry of Foreign Affairs is in place (except for citizens of the US, Austria, Spain, Belgium, Germany, Great Britain, Italy, France, Japan, Switzerland, Latvia and Malaysia).
7. Incomplete visa applications are not accepted. A personal interview with an applicant may be required. In case any person is declined to obtain entry visa to Uzbekistan, the Consular Section of the Embassy reserves the right to provide no explanation.
8. For citizens of the US, Austria, Belgium, Germany, Great Britain, Italy, France, Japan, Spain, Switzerland, Latvia and Malaysia visas are issued within 3-4 working days. For citizens of other countries processing of visa applications may take up to 10 working days (except for transit visas and those cases when visa support is already arranged and transmitted to the Embassy).

### BUSINESS VISA

1. Original Passports with minimum 6 months validity from date of travel, also attach old passports (if any), must have 1 Or 2 black paper.
2. Visa Application Form to filled and duly signed by the applicant.
3. 2 attached recent photographs to your application forms.





4. Copy of the letter of invitation from inviting partners in Uzbekistan (travel agents, Tourist Company or etc.) (Except for citizens of the US, Austria, Belgium, Germany, Great Britain, Italy, France, Japan, Spain, Switzerland, Latvia and Malaysia).
5. Fees. To be paid on collection only.
6. Applying by courier service or mail. Before sending your documents please contact the consular section to assure that visa issuance confirmation of the Ministry of Foreign Affairs is in place (except for citizens of the US, Austria, Spain, Belgium, Germany, Great Britain, Italy, France, Japan, Switzerland, Latvia and Malaysia).
7. Incomplete visa applications are not accepted. A personal interview with an applicant may be required. In case any person is declined to obtain entry visa to Uzbekistan, the Consular Section of the Embassy reserves the right to provide no explanation.
8. For citizens of the US, Austria, Belgium, Germany, Great Britain, Italy, France, Japan, Spain, Switzerland, Latvia and Malaysia visas are issued within 3-4 working days. For citizens of other countries processing of visa applications may take up to 10 working days (except for transit visas and those cases when visa support is already arranged and transmitted to the Embassy).
