

VENEZUELA

TOURIST VISA

1. Original Passports with minimum 6 months validity from date of travel, also attach old passports (if any).
2. Visa Application Form to filled and duly signed by the applicant.
3. 3 recent photographs 3 X 3 not scanned.
4. Covering letter from applicant mentioning the purpose of travel and duration of stay
5. Original leave letter from Employer / School / University.
6. Hotel confirmation.
7. Proof of Air Tickets.
8. Income Tax / Form 16 for last 3 years.
9. Original Personal Bank statements stamped & signed by bank for last 6 months with good transaction history & healthy balance. Also require is Letter from bank certifying opening date and good handling of your account.
10. Yellow Fever certificate.
11. Copy of Health Certificate against Ebola issued at least 21 days prior from the date of travel by any Government Hospital has to be submitted in the Embassy in order to get the visa application processed. The Health Certificate should state that the applicant is fit to travel to Venezuela. The applicant has to carry the Original at the time of travel.

BUSINESS VISA

1. Original Passports with minimum 6 months validity from date of travel, also attach old passports (if any).
2. Visa Application Form to filled and duly signed by the applicant.
3. 3 recent photographs 3 X 3 not scanned.
4. Covering letter specifying position held, purpose of the visit, responsibility of travel expenses, name and address the visa holder will be in contact with in Venezuela.
5. Company registration proof.
6. Original recommendation Chamber of Commerce.





7. Original invitation letter from the company the visa holder will be in contact with in Venezuela and the purpose of business.
8. Venezuelan Company's Commercial Registry and RIF.
9. Proof of Air Tickets.
10. Hotel confirmation.
11. Income Tax / Form 16 for last 3 years.
12. Salary slips for last 6 months (If employed).
13. Original Personal & Company Bank statements stamped & signed by bank for last 6 months with good transaction history & healthy balance. Also require is Letter from bank certifying opening date and good handling of your account.
14. Yellow Fever certificate.
15. Copy of Health Certificate against Ebola issued at least 21 days prior from the date of travel by any Government Hospital has to be submitted in the Embassy in order to get the visa application processed. The Health Certificate should state that the applicant is fit to travel to Venezuela. The applicant has to carry the Original at the time of travel.
